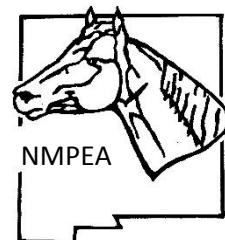

ELIGIBILITY:

1. Horse must be registered with Palomino Horse Breeder's of America (PHBA) as palomino or palomino bred. Open to horses from any state.
2. Exhibitor and owner must be current members of PHBA and NMPEA:
 - a. As a New Mexico affiliate member of PHBA. Copies of PHBA membership card(s) must accompany enrollment form with affiliate membership designated as NMPEA. **Note: A PHBA membership includes an affiliate membership. Your state affiliate is shown on your PHBA membership card on the upper right hand corner.** If you have recently completed your PHBA membership application and have not received your membership card, a copy of your application can be submitted with enrollment form.
 - b. Or, if a PHBA affiliate member of another state, by paying \$10.00 NMPEA associate membership fee (fee and NMPEA associate membership form must accompany enrollment form). Associate membership is good for one show season.
 - c. NMPEA membership is open to members from any state.
3. Enrollment form must be completed and send to NMPEA point keeper for each show season. **A copy of the horse's registration papers must accompany enrollment form.**
4. An annual \$5.00 (non-refundable) enrollment fee must be paid for each division – open, amateur and youth.
 - a. Open (junior or senior) horse: \$5.00 enrollment fee per horse must be paid prior to showing for points to count. Points accumulate on the horse, can have different exhibitors. Owner(s) and exhibitor(s) must be PHBA and NMPEA member(s).
 - b. Amateur and youth divisions: \$5.00 enrollment fee per horse and exhibitor team must be paid prior to showing for points to count. Points accumulate on a one horse/one exhibitor team. If multiple exhibitors (such as an amateur and youth showing the same horse) an enrollment fee is required for each horse/exhibitor team. An amateur or youth or novice must hold a PHBA amateur or youth or novice membership card. Owner(s) and exhibitor(s) must be PHBA and NMPEA member(s).
5. Qualifying dates for show season: November 1 – October 31 of following year.
6. Horse (or horse/exhibitor team) must show to at least three judges or at three separate competitions during the show season.
7. Points earned in all PHBA sanctioned classes during the show season at shows in NM will count towards year end awards. To encourage participation at PHBA sanctioned shows in NM, double points will be awarded for placings in PHBA approved classes at these shows.
8. Points earned at up to six non-PHBA sanctioned shows or events can be submitted to the point keeper (on approved reporting forms) to count towards year end award tabulation. Points earned in classes other than PHBA approved classes at a show that offers PHBA classes count as one of the six non-PHBA sanctioned shows that can be used for year end award tabulation (these classes do not count as an additional competition when meeting the three competition requirement to be eligible for year end awards).
9. Only points from shows held within the state of New Mexico will count towards year end awards.
10. All report cards (or approved substitutions) must be submitted to point keeper within 30 days after completion of a show (or by November 15 for shows on or after October 15).
11. To be eligible for year end awards, **ONE** of the following requirements must be met:
 - a. An enrolled horse must show in a PHBA sanctioned class at a NMPEA show during the show season.
 - b. The exhibitor or owner must work (or have someone work for them) a full day at an NMPEA show during the show season. This must be communicated to the point keeper in advance of the show where the work requirement will be fulfilled. The work requirement cannot be fulfilled by someone working in a paid position at the show.
 - c. OR, the exhibitor or owner must obtain \$50.00 or more in NMPEA sponsorships (due with enrollment form).



Important!!! All above requirements must be met before points will count towards year end awards. Enrollment form and fee must be postmarked and membership paid before points to count. Enrollment forms, fees and memberships can also be submitted and paid at NMPEA sponsored show prior to showing before points count towards year end awards.
