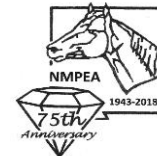
Stall Reservations for guaranteed stalls must be received by 10/15/19

A stall reservation form must be completed for each equine on show grounds during event whether working out of trailer or stalling on grounds.

Please consult with the NM Livestock Board for up-to-date requirements regarding equine transport within NM and into NM (if traveling from out of state) at www.nmlbonline.com or (505) 841-6161 or (800) 432-6889.

Owner/Agent/Exhibitor must check in with Show Secretary to verify entries, present registration papers, membership cards, and arrange payment with signed check or cash prior to showing.

Expo NM stalls and arenas will NOT be available for move in or schooling prior to 5 pm on Friday, October 25, without prior approval of show management.

Stalls: \$25 per day (or any part of day).

Tack Stalls: \$25 per day (or any part of a 24 hours period). For shared tack rooms, one exhibitor will be charged full tack room.

Show Secretary will not split tack room fees.

Tie Out (working out of trailer): \$15/day. No stall use permitted. Must complete reservation form.

Tack and Stall charges above include move in the evening prior to showing, i.e. if arriving on Friday evening or during the show on Saturday & showing on Saturday, 1 stall or tack will be charged. If arriving Saturday evening or during the show on Sunday & showing Sunday only, 1 Stall (or Tack) will be charged. If arriving Friday evening or during the day on Saturday and showing Saturday and/or Sunday, stalls (or tack rooms) will be charged for two days.

RV (or LQ) with Electric Hookup: \$35/day or night

RV (or LQ) without Electric Hookup: \$25/night (if staying overnight in trailer, you will be charged)

Shavings, hay and feed can be purchased from the feed store, 4W Feed, on the fairgrounds. Feed store onsite phone number (505) 259-5341. Please call ahead to order shavings and/or feed and to confirm hours feed store is open or to make arrangements to have shavings waiting at your stall upon arrival.
