### Year End Award Eligibility:

\*\*Qualifying shows dates: November 1 - October 31 of following year, i.e. the 2021 show season dates are 11/11/20 – 10/31/21.

Membership and Enrollment Open to Exhibitors, Owners and Horses from Any State.

Points are earned based on NMPEA point system.

Open points are based on horse (can have multiple exhibitors). Youth & amateur points are accumulated on one horse/one rider.

Only shows held within the state of NM will count towards NMPEA year end awards.

Showing Requirements	Must show in at least one PHBA class in their division (open, amateur, nov. youth, etc.)	Must show in at least one All Breed class in their division at an NMPEA sponsored show
	Horse (or horse and exhibitor team) must show to at least 3 judges or at 3 separate competitions in their division during the show season	
	Placings from a Class can be used in only one category either for Palomino, Palomino Bred OR for All Breed Year End Awards	
Double Points Can be Earned	In All PHBA Classes held in NM	For All Breed awards only: in All Breed Classes at NMPEA sponsored shows
Non-NMPEA Shows Can Count	Up to six non-PHBA (or non-NMPEA) shows or events can be submitted to NMPEA point keeper on an approved report card (or approved substitute) to count towards year end award tabulation. Report cards must be submitted within 30 days after show (& no later than November 15 for shows on or after October 15)	
Work or Sponsorship Requirement	The exhibitor or owner must work (or have someone work for them) a full day at an NMPEA show during the show season OR the exhibitor or owner must obtain \$50.00 or more in NMPEA sponsorships (due with enrollment form)
